01	OFFICE BEARERS OF SALKIA FRIENDS ASSOCIATION	An objection petition was submitted by Shri Pradip Kumar Basu, Hony. General Secretary of Salkia Friends Association to the effect that he did not receive the notice of AGM on 24.09.2026 and Appendix-A Form. He also has not signed the Appendix-A Form. On the basis of submission made by both sides in the Hearing along with the available documents, the Electoral Officer finds that as per Rule 33 of CAB Rules read with Para 2a of the Notice of Election, Appendix-A Form has to be signed by the Secretary/ General Secretary of the affiliated members unless there is any written authorization by the competent authority. Hence, the Appendix-A Form of Salkia Friends Association signed by Shri Tapan Kumar Chakraborty as Hony. Assistant Secretary is rejected.
02	SHRI YOGENDRA KUMAR CHOWDHARY AND SHRI RISHAV DUTT ON BEHALF OF BHUKAILASH SPORTING CLUB	An objection petition was received from Shri Yogendra Kumar Chowdhary to the effect that there was no Annual General Meeting of Bhukailash Sporting Club for last 31 years and there was no election for the post of Office Bearers. On the basis of submission in the Hearing and

		the available documents, the Electoral Officer finds that there is no specific reply regarding alleged non-holding of AGM rather the members of the running body desired the issue to be raised before any Hon'ble Court for necessary directions. This leads the Electoral Officer to believe that there is ample doubt about holding of AGM and election of the Office Bearers of the Club and, therefore, the status of current General Secretary is questionable. Hence, the Appendix-A Form submitted by Bhukailash Sporting Club is rejected.
03	SHRI NILMADHAB DUTTA REPRESENTING SHRI NIMAI CHARAN DUTTA AND SHRI SOMNATH GANGULY REPRESENTING HOWRAH SPORTING CLUB.	An objection was received from Shri Nimai Charan Dutta to the effect that Appendix-A Form has not been signed by the actual General Secretary of the Club. On the basis of submission in the Hearing and the available evidences the Electoral Officer finds that the Civil Judge (Junior Division), 3rd Court, Howrah in Title Suit No.1570 of 2025 restrained the Defendants Shri Nimai Charan Dutta and others which is extended upto 09.12.2026. The Misc Appeal no.2026 of 2025 filed by Shri Nimai Charan Dutta was ordered to be kept with the record and Ld. Addl. District Judge, 4th Court vide Order No.9 dated 29.01.2026 rejected the stay petition dated 10.12.2025. In view of above, the Electoral Officer finds that Shri Nimai Charan Dutta has been restrained by order of the competent court not to be associated in any manner with the affairs of Howrah Sporting Club. Hence, the Appendix-A Form signed by Shri Somnath Ganguly as Hony. General Secretary of the Club is accepted.
